### 2019 MEMBERSHIP CLASSES

All members are subject to food minimums and an annual capital improvement fee.

\*\* Family membership includes children 25 years of age or younger, residing in the primary member's home.

#### **Full Golf**

Members have full golfing privileges and full use of the Club facilities, including pool, tennis and dining.

#### **Intermediate Golf**

Members are ages 25-30 years old with full golfing privileges and full use of the Club facilities, including pool, tennis and dining.

#### **Senior Golf – For our members 70 years of age +**

Members may play weekday only (no holidays), tennis, pool and full use of the Clubhouse facilities. Tournament play permitted with payment of applicable greens fee in addition to tournament fee.

\*Tournament fees are charged to all participants regardless of membership class.

#### **Pool/Tennis**

Members have full use of the pool, tennis and Clubhouse facilities. Limit of four (4) rounds of golf per family but must pay guest fees.

#### **Clubhouse**

Members have full use of the Clubhouse for dining and entertainment only. No Golf, Tennis or Pool facilities included.

**Glenhardie Clubhouse Dress Code**

Glenhardie strives to be a relaxed and inviting club for all members. We have adopted a dress code that is befitting our casual yet professional culture. Please adhere to it. Appropriate country club casual dress is required at all times, in all areas. Not permitted: short shorts, muscle shirts, inappropriate t-shirts, swim attire, etc. Also, all caps and hats worn by men must be removed while in the clubhouse. Jackets are encouraged for gentlemen dining on Saturday night in the Main Dining Room from Labor Day to Memorial Day, otherwise a collared shirt is required. Appropriate denim is permitted in all areas of the Clubhouse at all times. Bathing suits and swim attire are permitted only in the pool and adjoining terrace areas.

Members or their guests violating these rules may be warned or asked to leave the premises. Please advise your guests of our policy. Staff members are authorized by the Board of Directors to uphold the dress code.

**CONDITIONS: Please Read**

- Guests must be accompanied by a member and each Guest is permitted a maximum of four (4) visits per year for golf, pool and tennis.
- Account statements are due upon receipt and members whose accounts are 30 days past billing date shall be charged a 1.5% late fee.
- Your credit card will be charged automatically if payment has not been received 90 days after billing date. If the card on file is out of date or denied for any reason your membership shall result in suspension of all club privileges until your account is paid in full.
- All Membership dues and fees are payable for an entire calendar year. (January 1 to December 31)
- Resignations prior to the end of a calendar year do not remove a member's obligation to pay dues, charges, assessments and fees for the entire year. Membership may be terminated only upon written notice to the business office.
- In case of termination, no dues, capital improvement or other fees or any part thereof will be refunded for any reason. Dues paid are for the current calendar year.
- Membership renewal dues will be billed in September (due December 31) for the following year.
- In the event of a change in membership to a class with greater annual dues or initiation fee, the annual dues or initiation fee previously paid will be credited toward the new class Requirement and due in full at time of upgrade.
- Glenhardie Country Club has and otherwise reserves the right to photograph Members and/or guests on Club premises without compensation or consideration to the Members and/or guests who are photographed. All photographic documentation becomes the property of and may be used by Glenhardie Country Club for marketing, website distribution or other purposes. No personal names or addresses of photographic subjects will be displayed or disclosed without prior approval by the subject Members and/or guests involved.

 Last name ending A to G – Cycles end March 31, June 30, September 30 & December 31  
 Last name ending H to M – Cycles end January 31, April 30, July 31 & October 31.  
 Last name ending N to Z – Cycles end February 28, May 31, August 31 & November 30.
